- You have received or are eligible to receive an ACT or SAT testing fee waiver
- You are enrolled in or eligible to participate in the federal free or reduced price lunch program (FRPL)

Fee Waiver - Common Application You may qualify for a fee waiver if your household income is at or below 150 percent of the Federal Poverty Guidelines at the time you file. Check the current poverty levels for this year at Form I-912P, HHS Poverty Guidelines for Fee Waiver Requests. You must list the head of household's income on your fee waiver request.
