The emphasis on

early initiation of chest compressions without delay for airway assessment or rescue breathing has resulted in improved outcomes. (ACLS) 2015 - 2020 BLS Guidelines Changes The 2015 guideline now defines the target depth for adult compressions to be between 2-2.4 inches (5-6 centimeters).
