Renton Your gambling winnings are generally subject to a flat 24% tax. However, for the following sources listed below, gambling winnings over \$5,000 are subject to income tax withholding: Any sweepstakes, wagering pool (including payments made to winners of poker tournaments), or lottery. A payer is required to issue you a Form W-2G, Certain Gambling Winnings (PDF) if you receive certain gambling winnings or have any gambling winnings subject to federal income tax withholding. You must report all gambling winnings as "Other Income" on Form 1040 or Form 1040-SR (PDF) (use Schedule 1 (Form 1040 or 1040-SR) (PDF)), including winnings that aren't reported on a Form W-2G (PDF) . More than \$5,000 in winnings from a poker tournament Any winnings subject to a federal income-tax withholding requirement If your winnings are reported on a Form W-2G, federal taxes are withheld at a flat rate of 25%. If you didn't give the payer your tax ID number, the withholding rate is 28%. Gambling Winnings Tax | H&R Block You must itemize your deductions to claim your gambling losses as a tax deduction. This means you can't take the standard deduction for your filing status, which often amounts to more than a taxpayer's itemized deductions. You're allowed to deduct losses only up to the amount of the gambling income you claimed. So if you won \$2,000 but lost \$5,000, your itemized deduction is limited to \$2,000. In this instance, you won't owe tax on your winnings because your total loss is greater than your total win by \$2,000.
